Duties; first meeting; membership; funding. The work group shall evaluate and 21 prioritize actions that can help communities and businesses in the State adapt to climate 22 change by identifying new opportunities and minimizing economic and environmental 23 impacts. The Department of Agriculture, Conservation and Forestry shall invite to the 24 initial meeting of the work group representatives of the University of Maine System, 25 nonprofit organizations, business associations and municipalities and individuals and 26 representatives of businesses with expertise and interest in climate change adaptation. 27 Members of the work group shall coordinate efforts to secure funding from 28. nongovernmental sources to assist with costs of the work group related to facilitation, 29 30 analysis and report generation. 2. Agency participation. On the effective date of this resolve, the Department of 31 Agriculture, Conservation and Forestry shall provide to the Joint Standing Committee on 32 Environment and Natural Resources the names of agency personnel who will participate 33 34 in the work group. including any proposed implementing legislation, to the joint standing committee of the

Legislature having jurisdiction over environmental and natural resources matters. The joint standing committee is authorized to report out a bill to the First Regular Session of the 127th Legislature.'

4 SUMMARY

This amendment is the majority report of the committee and replaces the resolve. The amendment directs staff with planning expertise within the Department of Agriculture, Conservation and Forestry, within existing resources, to participate in a work group with other state agencies and interested parties to develop a plan to address high-priority recommendations provided in the report titled "People and Nature Adapting to a Changing Climate: Charting Maine's Course." The amendment directs the work group to submit a preliminary report by March 15, 2014 and a final report by January 15, 2015 to the joint standing committee of the Legislature having jurisdiction over environmental and natural resources matters. The joint standing committee is authorized to report out a bill to the First Regular Session of the 127th Legislature.
