

Point East—a real-estate development company based in Greenwich, Connecticut—wants Wiscasset to change the zoning rules to allow them to build a giant coal plant and diesel refinery in our town.

Wiscasset has a zoning ordinance that sets 60 feet as the maximum height for new construction. Point East wants that limit raised to 230 feet—nearly 4 times higher. Approving the new height limit would clear the way for Point East to build a huge, noisy industrial complex with enormous smokestacks that would tower over everything else in town.


Operating around the clock, the plant would consume 14 million pounds of coal every 24 hours, producing nonstop noise and dust.

Right now the choice is up to you. Wiscasset voters can block Point East's scheme on November 6, 2007.

OUR HEALTH. OUR CHILDREN'S HEALTH

The proposed plant would release 22 pounds of mercury into the local air every year. That is nearly 50% more than the Dragon Cement plant and twice as much as the now-defunct HoltraChem plant.

MAINE'S LARGEST SOURCE OF GLOBAL WARMING

The plant would release more carbon dioxide than all other power plants in Maine combined. Carbon dioxide is a greenhouse gas and the biggest source of global warming.







DRIVING OUT FISHING FAMILIES

A 400-foot barge with an 80-foot tugboat would use the Sheepscot River almost daily to feed the plant's appetite for coal. The river would turn into a barge canal. Barge traffic would cripple the lobster industry and threaten shellfishing and worm harvesting.

BAD CHOICE FOR WISCASSET'S FUTURE

- The only place that coal barges can land is at Mason Station. That means instead of condos, shops, restaurants, and a marina, the maritime village would become a 2-million-ton-per-year coal pile.
- A noisy, gritty, smelly coal power plant and diesel refinery will drive away visitors and devastate the local businesses that rely on them.
- The threat of a coal plant will scare away moredesirable businesses and has already started to drive down property values.
- Do we want to ruin the town's character and risk a dirty legacy for our children and grandchildren?
