Overwhelming Opposition to Mining Rules Demonstrated at Public Hearings

The Environment and Natural Resources Committee held two major public hearings on the mining issue (LD 146 and LD 750 amended) which demonstrated that Maine people from all parts of the state oppose weak mining rules. Twenty-four people from Aroostook County testified in person or submitted comments in opposition to the rules. Only two people from Aroostook County testified in support of the rules. Individuals from 77 Maine communities spoke at these two hearings or submitted comments in opposition, with the highest number of opposition comments from any one town coming from Presque Isle. Only 13 individuals *total* testified or submitted comments in support of the rules – almost all of whom were lobbyists for Irving, LLC. or represented consulting firms that would benefit from mining in Maine.
