Dear Senator Collins:

The Board of Directors of the Katahdin Area Chamber of Commerce (KACC) is writing to ask that you support the creation of the above referenced National Park and National Recreation Area. We believe that this substantial investment in our region will strengthen the local economy, create new jobs and help to turn the tide on the declining population in the Katahdin Region.

The KACC currently serves 140 members in the communities of Millinocket, East Millinocket, Medway, Lincoln, Patten, Sherman, Brownville and surrounding unorganized townships, as well as member businesses and organizations in Greenville, Skowhegan, Augusta, Ashland, Mt. Chase, Springfield, Hampden and Presque Isle. Our mission includes, but is not limited to, assisting in the development of recreation and tourism businesses and opportunities related to our local natural resources to provide jobs for people in the Katahdin Region; and, encouraging and assisting with community developments that result in improvements to the business and community infrastructure in the Katahdin Region.

Elliotsville Plantation, a privately owned, Maine-based foundation, would like to donate up to 150,000 acres of land to create a National Park and National Recreation Area (NRA) (75,000 acres respectively) east of Baxter State Park along the East Branch of the Penobscot River. In addition, Elliotsville Plantation would create a substantial endowment for the permanent maintenance and operation of the park and recreation area.

The National Park would provide hiking, bicycling, snowshoeing, cross-country skiing, camping, paddling, fishing, wildlife watching, horseback riding and scenic drives as well as the preservation of natural, historic and cultural resources. The National Recreation Area (NRA) would allow hunting and snowmobiling as well as the aforementioned recreational activities.

Headwaters Economics, an independent nonprofit research group that assists the public and elected officials in making informed land management and community development decisions, outlines the economic benefits of a new National Park and NRA for Penobscot and Piscataquis counties in two comprehensive studies as well as a summary report of the two studies' findings, all available at http://headwaterseconomics.org/land/reports/katahdin. The reports were created using independent data and conservative methodology, and have been peer reviewed by leading Maine economists, including Charles Colgan, David Vail and Rob Lillieholm, who verified that the studies' approach and findings were sound.

The KACC encourages you to review this information. It provides compelling evidence of the value of National Parks and National Recreation Areas to 16 communities similar to the two-county region in Maine.

The economic performance, diversifying economies, and potential job creation findings were positive and telling, especially in peer regions with National Parks alone or with National Parks with nearby National Recreation Areas; but were not as consistent in peer regions with NRAs alone.

The reports also found that the impact on the timber industry on 150,000 acres of private land would be extremely small. The land is 80 percent forested and could produce, at most, 120,000 tons of green fiber per year, representing less than one percent of Maine's annual fiber utilization. Sustainable forestry on this amount of acreage would employ 21 people to bring the wood to the mills, and it is unlikely that this would produce more mill jobs. At most, with indirect jobs in mind, annual overall timber operations could potentially yield a total of 50 local jobs. It is understood by the Board of Directors of KACC that this is irrelevant in that the current owners of this property do not plan to harvest the timber in the absence of a National Park, except for minimal harvesting for wildlife habitat maintenance.

For those concerned about its impact on industry, since the establishment of the Clean Air Act in 1977, there are no examples where air quality standards of a region have been made more stringent due to the establishment of a new National Park.

With the declining population and loss of a great part of our primary industry in the Katahdin Region, the KACC Board of Directors views the possibility of this National Park and NRA, with its abundant and unique forestland, rivers, lakes, streams, ponds, wetlands, spectacular falls, rare plant species and interesting geological features (such as Haskell Rock and Grand Pitch), as a potential avenue for viable, long-term employment. The economic reports predict a National Park and National Recreation Area would create approximately 1,000 jobs in both the private and public sectors, and would strengthen tourism and recreation in the region.

It is also reasonable when considering a broader economic strategy that the communities surrounding the National Park and NRA would optimize the potential benefits with improved educational facilities, services and municipal infrastructure, thereby creating even more jobs.

The proud heritage of the Katahdin Region will be sustained if we are able to include conscientious tourism and recreation in the economic equation. The region's awe-inspiring natural resources are a gift to be cherished and shared. Elliotsville Plantation is offering a piece of this gift, preserved for generations to come in the form of this National Park and NRA. It is important to our communities that our native sons and daughters, as well as others with love for this area, have a reason and a means to live and thrive here, growing their families and bringing businesses, industries and prosperity to the Katahdin Region.

It is with all of this in mind as well as our mission components stated above and the thoughtful consideration of this proposal, that the Board of Directors of the Katahdin Region Chamber of Commerce hereby offers its enthusiastic support for the 150,000-acre Katahdin Woods & Waters

I am writing to inform you that the Board of Directors of the Maine Innkeepers Association recently voted to endorse the most recent proposal by Elliotsville Plantation Inc. (EPI) to create a national park and national recreation area on land east of Baxter State Park.

I recently had the pleasure of meeting Lucas St. Clair, the President of Elliotsville Plantation Inc (EPI). My presumption is either you or your staff have met with him and discussed his vision of creating a national park and recreational area of around 180,000 acres east of Baxter State Park, anchored by about 100,000 acres he owns and would like to donate to the US National Park service. In his presentation, Lucas was both a good speaker and a good listener. He seems to have rebooted this long debated and contentious idea of a national park into a more concise, thoughtful, and pragmatic package.

During the 37 years I have been involved with the forest products industry in Maine, I have always been a strong supporter of private property rights. Landowners should be able to do want they want with their land, so long as they do not negatively affect legitimate public resources. If EPI wants to donate land to the National Park Service, and if they want to accept it, then I think he should be able to do so.

There is a concern often expressed that a new national park in Maine would have a detrimental effect on the forest industry. Wagner manages 1.1 million acres of land in Maine; we depend on strong, vibrant, and dependable mills to buy our wood. It is my opinion, a 180,000 acre national park where wood is no longer harvested, would not have a noticeable impact on the wood using facilities in the region

I believe this area of Maine could use the economic diversity of a national park, and the existence of a new park would not have a deleterious effect on the forest product industry. The devil is always in the details but I think the plan Lucas is putting together is thoughtful and realistic. I support his plan and I hope you too can support the idea of a national park and help it come to pass.

RE: Letter of Support for Katahdin Woods & Waters National Park and National Recreation Area

To the Honorable Members of Maine's Congressional Delegation:

I am writing to you today on behalf of the Board of Directors of Katahdin Friends, Inc. (KFI) which recently voted to support the Conceptual Framework for Legislation to establish the Katahdin Woods and Waters National Park and National Recreation Area. KFI is an award-winning non-profit organization headquartered in Millinocket, Maine with offices in Lincoln, Bangor, and Portland which provides customized supports for people with disabilities — primarily people with intellectual and developmental disabilities — to live in homes of their own, work in regular community businesses, and participate in their communities as typical citizens.

I am a lifelong citizen of Millinocket as are six of KFI's nine Board members. KFI's Board is representative of the forest products industry, education, healthcare, law, business and finance, and people with disabilities. This diverse group of people, which includes people who may still be struggling with some of the issues surrounding the establishment of a national park, voted **unanimously** in support of one.

The reasons to establish a national park and recreation area are obvious to many of us who have spent our lifetimes in the Katahdin region. For over 100 years citizens directly and indirectly enjoyed the economic benefits of

the paper making industry. Those days are gone. A national park and recreation area has the potential to bring significant economic growth to our area, including job creation for people with and without disabilities.

An independent economic evaluation of the plan produced by Headwaters Economics, an independent non-profit research group that assists the public and elected officials in making informed land management and community development decisions, found compelling evidence for the park and recreation area. Most impressive about the report are the statistics about the vitality of communities surrounding similarly situated parks in our country.

The reports found that a new park and recreation area would have a very small impact on the timber and wood products industry, while at the same time creating as many as 1,000 new jobs and helping to improve overall economic performance and grow personal income in a host of professions. There is no reason why a national park and the forest products industry cannot thrive in the same region.

There are two compelling arguments to establish a national park from KFI's standpoint. One is the obvious advantage all citizens, including people with disabilities, would have in obtaining community employment. The second is the physical access a *national* park and recreation area would provide to people with mobility differences, much better suited than nearby Baxter State Park.

We at KFI urge you to strongly consider the 150,000 acre gift of land from Roxanne Quimby as an economic gift to the Katahdin region. The addition of hunting and snowmobiling in the recreation area combined with traditional uses in the national park will no doubt draw many new visitors and residents. And a \$40 million endowment for permanent maintenance of the park and recreation area is a lasting gift to us and the National Park Service.

We ask that you join us in support of the creation of a new national park and national recreation area in the Katahdin region. We ask that you do so with the sense of urgency that the situation demands. Our communities are dying. We believe this project is the resuscitation needed to breathe new life into the Katahdin region. We believe it will benefit all of its citizens, most especially our friends and neighbors with disabilities.
