Civic engagement is the heart of our work toward a clean energy economy. NRCM's leadership most recently resulted in a landmark climate policy requiring Maine to reduce its carbon emissions 80% by 2050 and establish the first Climate Action Plan in 15 years as a path to achieve that goal.
