

# Cultivating a Maine That Unites Us

ow more than ever, community is essential if we're to continue making progress that ensures a clean and healthy Maine for all of us, for generations to come.

At times, it may seem that there is more that divides our world, our nation, and our state than unites us. Certainly, we can't all agree on everything all of the time, but clean air and water, vibrant forests, healthy wildlife, and places to get out and enjoy it all—there's no debating that these things are essential.

Fortunately, the NRCM community is as strong as ever. Together, we made tremendous progress this year advancing clean energy. We made gains in conserving Maine's North Woods, including our dwindling older growth forests—increasingly rare habitat essential for many species of high conservation concern. We took steps to protect water quality and to reduce food waste. We helped improve transportation options by supporting efforts to develop several new bike paths and by advocating successfully for legislation that improves our statewide public transit system to ensure expansion of service and better ride coordination.

Success like this doesn't happen by chance. People must be informed and willing to speak up. That's why community is so important—it lifts all voices. Like birds in a flock and schools of fish that swim as one, we are most impactful when we move together.

A major collective achievement was passing a bill requiring Maine to achieve 100% clean electricity by 2040. Research has shown such a move could save Mainers as much as \$1,300 annually on energy bills, and the benefits to the environment would of course be priceless. This victory was a shining example of the environmental community— NRCM supporters, coalition partners, clean energy business leaders, and legislators—working together to address the most pressing issue of our time: climate change.

Sometimes, an important part of our shared commitment means stopping bad things from happening. This year we saw the highest number of rollback bills in more than a decade. These attacks included proposals to overturn Maine's ban on single-use plastic bags, efforts to delay implementation of the packaging waste law, and attempts to create a loophole in Maine's Bottle Bill, repeal clean energy goals, and weaken mining laws that protect clean water. We remained strong, fortified by one another, and most of these harmful bills were defeated.

NRCM is making it a priority to cultivate a Maine that brings people together. With dedicated staff in Franklin County, the Midcoast region, and others who travel across

the state, we are hearing directly from more voices than ever. We redesigned our visual identity this year in part to signal that, as we reflect and build on the strength of our past, we are looking to the future, listening to those who have felt marginalized, unheard, or that their voices do not matter. To that end, other changes are in the works to ensure we hear and amplify as many Maine voices as possible.

NRCM has been a leading voice for Maine's environment since 1959, when a handful of concerned individuals put aside any differences so that, collectively, they could let decision-makers know they felt the Allagash was worth protecting. Since then, the NRCM family has been blessed with a pantheon of talented staff and board members, thousands of dedicated volunteer supporters, a wide range of coalition partners and funders, and an incredible number of organizations and businesses that share our passion for protecting Maine's environment.

The backbone of Maine's economy is our natural resources. Those resources provide the food and water that sustain us; the materials that build our homes; the trails we hike and ride; the waters we sail, paddle, and fish; and especially right now, the vistas that inspire us, give us joy, and lift us up. These resources must be protected.

Thank you for joining us in speaking with a strong, unified voice. That's the strength of NRCM—all of us coming together to speak up for Maine's environment.

# **Celebrating Our Time Together**





Participants shared about the harm caused by blocking, freezing, and reversing critical federal investments and the elimination of staff positions at federal agencies.

## Restoring Maine's Rivers

**9,039,2451** Another record-setting number of alewives and blueback herring that passed through Benton Falls this year to reach spawning habitat. This milestone shatters last year's record of 6,551,356 and was only possible because of the removal of Edwards Dam in Augusta. NRCM continues to make removal of the four dams above Waterville a high priority and is thrilled that a deal has been reach to sell the dams for removal.

**5,926,084** Number of alewives that passed through Milford Fish Lift to reach upstream Penobscot River habitat to spawn. This vast number is the result of the Penobscot River Restoration Project that removed two dams and created a nature-like bypass at another. NRCM was a founding member of this project.


